This meeting will be held under the General Regulations of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA), and these Supplementary Regulations.

Eligibility

The event is open to all fully-elected members, who are eligible to enter/drive competitive events, of AROC, ALRC, CVLRC, P&D LRC, BHCLRC, SROC, Midland ROC, AWDC, BADLRC, SCOR, LRLRC and all Association of Land Rover Club affiliated clubs. Clubs require to be MSUK Registered.

All entrants must produce a club membership card of the club in which they belong and their MSUK RS Clubmans licence. Both must be presented to the secretary of the meeting at signing on.
